LAUFEN CZ

- 1/ The customer (buyer, installation company, or the end user) must check the product at receipt in the store and before installation. Later complaints against installed products with apparent defects and products with incorrect color shades will not be accepted.
- 2/ The warranty does not apply to damage incurred due to non-compliance with the instructions provided in the installation guide for given product.
- 3/ The warranty does not apply to any damage of the product caused by the customer, transportation, improper handling and storage of the product, or improper installation, inadequate use or improper maintenance of the product, and by dirt penetrating into the product. The product should be installed in strict compliance with the installation instructions. Laufen levelling compound, or the adequate Laufen sound reduction pads must be used for installation of Jika, Laufen, Roca ceramic products.
- 4/ Bathtubs must be installed according to the installation instructions. The LAUFEN CZ Company will not reimburse any costs associated with damage to tiling, paving or masonry which may be incurred if these instructions are not followed. In case of any complaint, the product should be easily removable.
- 5/ Only suitable detergents may be used for cleaning of products.
- 6/ Any complaint will be managed by the dealer who sold the product subject to complaint to the customer, or by an authorized service center.
- 7/ The warranty period will commence from the receipt of the product by the customer (printed by the dealer on this warranty certificate). If the purchased product should be installed by a person other than the selling (installation) company, the warranty period will commence from the date that the product is put in operation if the installation is ordered by the customer within three weeks from the receipt of the product.
- 8/ A product complaint will not be accepted without proof of purchase.
- 9/ The customer will bear all costs of the service technician associated with an unjustified complaint if the unjustified complaint involves a trip of the service technician to the customer.
- 10/ Bathroom furniture cannot be exposed to long-term effect of standing water or extremely high air humidity. Use only non-abrasive cleaners, e.g. soft cloth and soapy water, for furniture cleaning, and dry up furniture after cleaning.
- **11/** The warranty does not apply to any product samples acquired from exbititions and showrooms.

Additional warranty conditions applicable to water faucets:

- 1/ Water faucets must be cleaned regularly using detergents solely intended for this purpose to avoid scale build-up.
- 2/ Use a spray bottle to apply detergent to the surface to be cleaned. Aerosole may penetrate into the inner parts of valves causing damage. Therefore, apply detergent to a cloth or sponge and only then clean the surface.
- 3/ Do not use cleaning agents containing acetic, phosphoric, formic, or hydrochloric acid. Further, do not use chlorine-based bleaching agents. They may cause irreparable damage to the product.
- 4/ Do not use scrubbers, sponges and cleaning detergents that may scratch the surface.
- 5/ Remove detergent residue from the product within 10 minutes using a sufficient amount of clean water.
